Notice of the proposed adoption of the respective Resolutions by each School District, containing a summary of the Resolution, was published in the Lancaster Intell/New Era on September 28, 2011. The substance of the amendments made in the Resolution of each respective School District during passage are as follows: 1. The resolution, as adopted in different form with different numbers for each School District, authorized each respective School District to incur lease rental indebtedness in the following maximum principal amount, with maximum lease rental payments in a range indicated in the parenthetical: Cocalico S.D. \$2,035,801 (\$105,786 to \$192,771) **Columbia Borough S.D. \$459,658 (\$23,931 to \$43,608)** Conestoga Valley S.D. \$3,674,501 (\$191,221 to \$348,455) Donegal S.D. \$1,538,635 (\$80,067 to \$145,903) Eastern Lancaster County S.D. \$2,893,761 (\$150,516 to \$274,281) Elizabethtown Area S.D. \$2,076,558 (\$108,023 to \$196,847) Ephrata Area S.D. \$2,531,490 (\$131,730 to \$240,047) Lampeter-Strasburg S.D. \$2,337,086 (\$121,666 to \$221,707) School District of Lancaster \$3,286,019 (\$170,869 to \$311,368) Manheim Central S.D. \$2,260,872 (\$117,640 to \$214,371) Manheim Township S.D. \$4,338,384 (\$225,663 to \$411,218) Solanco S.D. \$2,734,760 (\$142,241 to \$259,202) Warwick S.D. \$2, 717,145 (\$141,347 to \$257,572) 2. Lease rental payment dates and maximum annual lease rental payments were authorized and are to be paid by each School District under the terms of a Lease Agreement by and between the School Districts and the Lancaster County Career and Technology Center Board, as lessees and Lancaster County Career and Technology Center Authority (the "Authority"), as lessor, which has been authorized and approved by each School District. The lease rental payment schedule and maximum annual lease rental payments are connected to the debt service requirements of the underlying bonds to be issued by the Authority.
