

## RESTAURANT INSPECTIONS

The Pennsylvania Department of Agriculture, 866-366-3723, uses a "risk-based" inspection reporting process for restaurants and other food handlers. The following inspection reports were completed Oct. 3-11.

**5 and Dime Neighborhood Mart**, 752 E. Ross St., Oct. 3. No violations.

**A&M Grocery**, 567 S. Lime St., Oct. 3. No violations.

**Ancient Order of the Croaking Frogs**, 300 Park Ave., Quarryville, Oct. 3. No violations.

**Applebee's Neighborhood Grill & Bar**, 320 E. Main St., Ephrata, Oct. 4. Bartender handled apple balls for drinks using his bare hands. Corrected. Utensils at bar stored with food contact surface up. Corrected. Deeply scored and stained cutting boards, replace or resurface. Several stored knives in back prep room were not clean to sight and touch. Corrected. Carts need to be cleaned. Numerous clean metal inserts found stacked wet. Corrected. Large

plastic lids stored on floor in back kitchen. Corrected. Recyclable containers found overfilled, preventing covers from closing securely.

**Aromas Del Sur**, 548 S. State St., Ephrata, Oct. 4. Food handler wearing a bracelet. Corrected. Bulk ingredient scoops hung on nails are making contact with the wall. Corrected. Tongs stored on oven handle between use. Corrected. Coating on shelves in four-door refrigerator is flaking off. Correct so that it is a smooth, easily cleanable surface. One deformed rubber spatula found. Corrected. Bottom shelves of prep tables are raw wood and are in poor condition. Seal or replace. Droplets of grease on Ansul system and on hood baffles. Can opener blade is worn and needs to be replaced. Most cutting boards are very scored and need to be resurfaced or replaced.

**Balan Mini Market**, 239 Juniata St., Oct. 7. Date and label all potentially hazardous foods. Provide pump soap at hand sink

in kitchen area. Dish soap is not appropriate.

**Barr's Farms**, 23 N. Market St., Oct. 7. No violations.

**Bauer Beverage**, 136 S. Water St., Oct. 3. No violations.

**Burger King No. 2617**, 310 N. Reading Road, Ephrata, Oct. 3. Internal temperature of green salads in display case for half an hour had internal temperature of 64 F. Unit had not been turned on. Food returned to walk-in to cool. Soda machine heads and nozzles were not clean to sight and touch. Corrected. Walk-in freezer floor needs a thorough cleaning.

**Centerville Middle School**, 865 Centerville Road, Oct. 5. No violations.

**Community Natural Food Store**, 128 E. Main St., New Holland, Oct. 5. Quaternary test strips are not available for ensuring correct sanitizer concentration. Light visible under exit

door in stock room. Seal to prevent vector entrance.

**Congregation Degel Israel**, 1120 Columbia Ave., Oct. 6. The refrigerator for meat storage was maintaining a temperature of 50 F. There are no potentially hazardous foods being stored in it. A call was placed for repair. Loose and cracked tiles at the floor drain in the food prep area. Person in charge states they are scheduled to be replaced.

**Donegal Middle School and Riverview Elementary School**, 1175 River Road, Marietta, Oct. 3. No violations.

Three-compartment sink system will be used until the mechanical dishwasher is repaired. Clean plastic Cambros and metal inserts in the food prep area stored wet in a manner that does not allow for draining and/or air drying. Repeat violation. Mops are not being hung to air dry.

Provide sanitizer and sanitizer test strips in deli area at all times.

**Fritz Elementary School**, 845 Hornig Road, Oct. 4. Observed small amount of pink and black residue on the drop plate of the ice maker.

Static dust on the fan guards in the walk-in cooler. Static dust on the filter over the pizza oven.

Clean grates and under grates at the fresh meat area. Accumulation of dust, dirt and debris observed. The hand sink for employees is not convenient and easily accessible, as evidenced

by the lack of proper handwashing by employees. Warehouse is extremely dirty, dusty and in need of cleaning.
