The new lieutenant went on to become Gen. James R. Jones, commandant of the Marine Corps, Commander of NATO Forces in Europe and later director of Homeland Security.

## Quarryville sidewalks are unneeded expense

I am writing about the curbing and sidewalks that the Borough of Quarryville is so persistent on going ahead with, no matter what the residents need, want or can afford.

I live on Summit Avenue, and I cannot cover the cost of putting in sidewalk and curbing. Then, in the winter, we will have to shovel the sidewalks. The plow will go down the street, and we will have to clear the sidewalks again.

I am a widow, 75 years old, and most of my neighbors are of that age, also. There is no need for sidewalks on this street. There are no businesses on Summit Avenue. It goes nowhere.

I had a gathering at my home last week to meet and greet some of the neighbors. Four called and said they would not be able to attend but I had 24 people here. We all had coffee and refreshments. No one wants sidewalks.

Doesn't Quarryville borough care what the residents want? After all we do live there.

We desperately need a traffic light at the intersection of State and Lime streets (Rt. 472), but it seems that has been put on hold for several years now. Quarryville had gotten three or four permits for this work to be done. The permits have since expired.

To my understanding, there have been fatalities and I feel it is more important to have that light installed. There are at least four to five accidents a month there. Where are the priorities of the borough? Lives to be saved or sidewalks that are not needed.

We are having a difficult enough time trying to pay our everyday bills, let alone adding an additional expense for sidewalks and curbing. This could be tabled and wait for another year when the economy is greatly improved. At that time, we could install a new council that could view the needs of the Quarryville residents.

The monies that have already been spent on engineering fees could also be put on hold for the time being.

This added expense has to be stopped.
