COLUMBIA BOROUGH POLICE

DAVID RAY STERLING, AGE 48, OF WRIGHTSVILLE, WAS CITED FOR PUBLIC DRUNKENNESS, ON COMMERCE STREET, 1915 HOURS, 13 JUNE 2013. HE WAS TRANSPORTED TO L.G.H. FOR AN OVERDOSE, AFTER A BREATH TEST REVEALED A HIGH READING THAT WAS CONSIDERED DANGEROUS.

CHRISTOPHER DAVID SMITH, AGE 23, OF LANCASTER, WAS CHARGED WITH D.U.I.; D.U.I. WITH A HIGH RATE OF ALCOHOL; AND WITH ONE-WAY ROADWAYS AND ROTARY TRAFFIC ISLANDS. SMITH TRAVELED THE WRONG WAY ON A ONE-WAY STREET AND WAS STOPPED FOR THAT VIOLATION, WHEN HE WAS FOUND TO BE UNDER THE INFLUENCE, 09 JUNE 2013, 0101 HOURS.

THREE FEMALE JUVENILES, AGES 12, 13, & 14, FROM COLUMBIA, WERE STOPPED AND CITED WITH RETAIL THEFT, WHEN THEY ATTEMPTED TO LEAVE THE DOLLAR GENERAL STORE, 960 LANCASTER AVENUE, COLUMBIA, WITH APPROX. \$62.00 OF ITEMS, BETWEEN THEM. THIS WAS 12 JUNE 2013, 1643 HOURS.

LINDSEY FARRON GARCIA, AGE 23, OF LANCASTER WAS CHARGED WITH POSSESSION OF HEROIN; POSSESSION OF DRUG PARAPHERNALIA; AND DRIVING WHILE OPERATING PRIVILEGE IS SUSPENDED OR REVOKED, 24 MAY 2013. HER BOYFRIEND, MICHAEL EUGENE ROOT, AGE 31, OF MANHEIM, WAS CHARGED AT THE SAME TIME WITH POSSESSION OF HEROIN; POSSESSION OF CLONAZEPAM; POSSESSION OF LORAZEPAM; POSSESSION OF DRUG PARAPHERNALIA; AND FALSE IDENTIFICATION TO LAW ENFORCEMENT AUTHORITIES.

WILBUR LEE SHULER, AGE 44, OF LANCASTER, WAS CHARGED WITH ACCESS DEVICE FRAUD AND FOR THEFT BY UNLAWFUL TAKING, 03 JUNE 2013. SHULER HAD STOLEN A WALLET FROM A WOMAN'S PURSE AT CVS. HE THEN WENT TO ANOTHER STORE AND USED ONE OF HER CARDS TO PURCHASE OVER \$80.00 WORTH OF ITEMS WITH IT.

JOSE LUIS TORRES, AGE 26, NO KNOW ADDRESS, WAS CHARGED FOR RETALIATION AGAINST WITNESS, VICTIM OR PARTY; CRIMINAL MISCHIEF; AND PUBLIC DRUNKENNESS. JULIUS BROCK TAYLOR, AGE 20, OF COLUMBIA, WAS CHARGED WITH RETALIATION AGAINST WITNESS, VICTIM OR PARTY AND FOR CRIMINAL MISCHIEF. TAYLOR WAS ALSO CHARGED WITH MANUFACTURE, DELIVERY OR POSSESSION WITH INTENT TO MANUFACTURE OR DELIVER COCAINE AND ALSO POSSESSION OF DRUG PARAPHERNALIA, 12 JUNE 2013, AFTER HE WAS PICKED UP ON SUMMARY OUTSTANDING WARRANTS.

ANGELA M. HERRING, AGE 26, OF COLUMBIA, WAS CITED FOR DRIVING WHILE OPERATING PRIVILEGE IS SUSPENDED OR REVOKED, IN THE 700 BLOCK OF PLANE STREET, 17 JUNE 2013.
