For years, we have read about the problems with the Lancaster Bureau of Fire. Interesting why so much angst about the fire department, but none about the police department.

There seems to be an abundance of police officers. Maybe some could train for the fire department and transfer their salaries to help the fire department.

Mentioning training brings to mind Mr. Gregg's comments about training "could include," "could happen," "likely to occur," "could do similar training." What nebulous comments, which leads me to believe that, when this tragedy blows over, it will be back to the old routine.

Nowhere in the report was there a mention of lack of enough personnel, or lack of enough equipment to do the job.

City residents are fortunate they have such dedicated firefighters who risk their lives every time the sirens go off. The chief and the mayor insist there needs to be 24-hour shifts. Do they not realize anyone on duty for 24 hours can't possible be alert enough to fight a fire?

Nowhere in the report does it mention Chief Gregg was not in command. Common sense tells me lack of leadership/command was what went wrong. Leadership starts at the top.

I vote for a lack of confidence for Chief Gregg and demand his resignation.
