

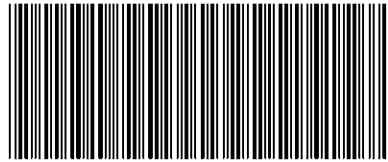

SHAWNEE STEAM FIRE ENGINE AND HOSE COMPANY NO. 3, THE SHAWNEE STEAM FIRE ENGINE AND HOSE COMPANY, SHAWNEE FIRE ENGINE & HOSE COMPANY, THE SHAWNEE STEAM FIRE ENGINE AND HOSE COMPANY OF COLUMBIA, PA and SHAWNEE STEAM FIRE & HOSE COMPANY #3 now known as COLUMBIA QUICK RESPONSE SERVICE INC.,

(hereinafter called the Grantor), of the one part, and

IRON BELL HOLDINGS II, LLC

(hereinafter called the Grantee), of the other part,

Witnesseth That the said Grantor for and in consideration of the sum of **One Hundred Thirty-Three Thousand and 00/100 Dollars (\$133,000.00)** lawful money of the United States of America, unto it well and truly paid by the said Grantee, at or before the sealing and delivery hereof, the receipt whereof is hereby acknowledged, has granted, bargained and sold, released and confirmed, and by these presents does grant, bargain and sell, release and confirm unto the said Grantee, as Sole Owner, its successors and assigns

PURPART A:

ALL THAT CERTAIN lot or piece of ground situate on the south side of Union Street between Fifth and Sixth Streets in the Borough of Columbia, Lancaster County, Pennsylvania.

BOUNDED on the north by said Union Street, on the East by property belonging to Ann Marks estate, on the South by other property of the said James Hollingsworth and on the west by property belonging to the said James Hollingsworth measuring in front on Union Street forty feet and extending of a like breadth one hundred and two feet more or less to the said property of James Hollingsworth.

PURPART B:

ALL THAT CERTAIN lot of ground with a two story, frame dwelling No. 524 Union Street thereon erected, situated on the south side of Union Street, between South Sixth Street and South Fifth Street, in the Borough of Columbia, Lancaster County, Pennsylvania, bounded and described as follows:

CONTAINING in front on the south side of Union Street, in front 25 feet, more or less, and extending in depth in a southwardly direction, uniform in width 100 feet, more or less to Carter Alley.

BOUNDED on the East by Corn Alley; on the South by Carter Alley; on the West by other property of the Grantee, and on the North by said Union Street.

PURPART C:

ALL THAT CERTAIN lot of ground, together with the frame dwelling house and other improvements thereon erected, situate on the south side of a ten feet wide private alley (which alley extends westwardly from Corn Avenue, parallel with Avenue N, turns at right angles and extends southwardly parallel with Corn Avenue to the north line of Avenue N), and known as Carter Alley, between South Fifth Street and Corn Avenue and Union Street and Avenue N, in the Eighth Ward of the Borough of Columbia, County of Lancaster and Commonwealth of Pennsylvania, bounded and described as follows:
